## The Aim of the International Conference

[www.conferinte-ince.ro](http://www.conferinte-ince.ro)

The aim of the international conference "Economic Scientific Research - Theoretical, Empirical and Practical Approaches"- ESPERA, initiated in 2013 by the National Institute for Economic Research "Costin C. Kirițescu" (NIER), is to present and evaluate the economic scientific research portfolio, to argue and substantiate the Romanian development strategies - including European and global best practices. The 2025 edition of the Conference will be held on **16<sup>th</sup> - 17<sup>th</sup> October**, under the title: **"Pivotal changes in the global landscape amid challenging conditions. Prospects for stronger resilience, potential disruptions and key governance policies"**.

The event program addresses a wide diversity of themes, bringing together researchers from all NIER institutes and centres, members of the Romanian Academy and also guests, from Romanian universities and from other countries, including master, PhD and post PhD students.

After the series of shocks in the previous years, in 2025 the global landscape is changing under the pressure of trade tensions escalation following the tariff measures introduced by the new US administration, bringing tariff rates to unprecedented levels and pushing its trading partners to respond with proportioned countermeasures, resulting a negative shock to economic activity and global growth.

The governments around the world are striving to reorder priorities, to resettle the international trade channels and supply chains, to address domestic policy and structural imbalances in such a way to ensure their internal economic and financial stability and security.

Under these circumstances, in order to contain vulnerabilities and increase resilience in case of stress events, macroprudential tools should be activated while rebalancing growth-inflation trade-offs, preventing severe disruptions, implementing credible medium-term fiscal consolidation plans, rebuilding buffers, restoring fiscal space and putting public debt on a sustainable path. All these should be complemented by structural reforms targeting labour markets, production, financial markets that support economic, social and environment resilience which help also narrowing cross-countries disparities.

Researchers are encouraged to present papers of scientific research regarding, as much as possible, the topics presented above.

Even if many of the papers deal with these aspects from the perspective of the impact and relevance of the analyzed aspects from the point of view of the Romanian economy and society, through the significant number of foreign authors participating in each of its previous editions, the ESPERA International Conference has proven its worth to act as a conducive forum for debating, sharing of knowledge and good practices with representatives of the academic environment, researchers and teaching staff from other countries, both from the European Union and non-EU countries.

For the editions ESPERA 2013 and 2014, after the evaluation, the most valuable 100 papers were selected for the Proceedings of the International Conference ESPERA, published on-line by Elsevier in "Procedia Economics and Finance" (vol. 8/2014 and vol. 22/2015); for the editions ESPERA 2015-2019, the most valuable papers were published at Peter Lang International Academic Publishing Group; for ESPERA 2020 the papers were published by Sciendo De Gruyter; for ESPERA 2021, 2022, 2023 the papers were published at Springer and for ESPERA 2024 most valuable papers are now in the final stage of evaluation at Springer and will be submitted to EBSCO and also for evaluation and inclusion in Conference Proceedings Citation Index by Clarivate, Web of Science.

The National Institute for Economic Research "Costin C. Kirițescu" (NIER), was reorganised in 1990 on the foundations of the Central Institute of Economic Research, borned in 1973.

NIER is an incorporated entity, and functions under the aegis of the Romanian Academy. NIER's main role is to conduct fundamental and advanced research work in the fields of economics, sociology, demography according to the research programmes proposed to and endorsed, on an annual basis, by the Department of Economics, Juridical Sciences and Sociology, and approved by the General Assembly of the Romanian Academy.

NIER has assumed the role assigned to it, as the highest rank economic scientific research forum of Romania, and bases its activity on three main pillars: the European and national economic and social development strategies, the European and national research and development strategies, and the mission of the Romanian Academy.



To perform NIER's mission of economic and social research, there are nine scientific units acting as incorporated entities under the current legislation, and working as part of NIER's network and under its scientific and administrative coordination. These are:

- a) Five research institutes: Institute of National Economy, Institute for Economic Forecasting; Institute of Agricultural Economics; Research Institute for Quality of Life; Institute for World Economy;
- b) Five research centers: Center for Industry and Services Economics; "Victor Slăvescu"; Center for Financial and Monetary Research; Center for Studies and Research on AgroForestry Biodiversity "Acad. David Davidescu"; Center of Mountain Economy and the Center for Economic Information and Documentation.

Also, under NIER's umbrella five unincorporated research entities are established: Center for Complex Researches; Romanian Center for Comparative Economics and Consensus; Center for Macroeconomic Modelling; Center for Demographic Research and Center for Renewable Energy and Energy Efficiency.
